EARLY CHILDHOOD PROGRAM

Early Childhood Education is the best foundation for success in future learning. Based on the belief that “Better Beginnings Yield Strong Completions”, St. Peter School offers families an outstanding developmentally appropriate pre-school program. Our multi-age Pre-K program accepts children who turn 3 on or before December 1, 2025 and operates five full days per week. All Preschool students must be potty-trained.

****The Pre-K Program follows the regular school day times and calendar, and participate in all special area classes: PE, library, art, music, technology & STREAM.**

PreK tuition is not a part of the multiple child discount noted above. If you have more than one child in the St. Peter Pre-K program, the Pre-K tuition for the second child is discounted by 30%. *You should check with your tax advisor to determine if any of the Pre-K tuition is eligible for tax credits or benefits.*

Parents who enroll children in both Pre-K and K-8 programs will receive a 10% discount of both the Pre-K tuition and K-8 tuition listed above.

Any student who spends three years, for whatever reason, in St Peter Pre-K program will be charged the regular K-8 tuition for the third year.

Tuition Assistance

Tuition assistance is available for grades K through 8. **Any families in need of tuition assistance *MUST* apply to the Bison Fund first to determine eligibility.** Once the Bison application has been received, families may submit an application for the St. Peter tuition assistance program. Requests must be made by submitting an application to FACTS who will make their recommendation to the Pastor/Finance Committee for a final decision. Funds are limited and will be allocated on a first-come, first-served basis.

Registration Fees - Early registration is encouraged to ensure your child’s place at St. Peter’s School and allow us to plan for the fall. The \$100 registration fee will be refunded if your circumstances change, and you notify us **before July 1, 2025.**

The annual cost per student at St. Peter’s School is approximately \$8,600. We work diligently to keep costs in order, are grateful for the support from the church, and believe the cost of tuition is a substantial value to our students and parents. Thank you for your support.
